**RESIDENTS (MS)**

**Crossbow Fee \$5.00 + Process Fee \$0.85 = Total Cost \$5.85**

Applicants age sixty-five (65) or older, must present proof of age only (copy of driver's license, birth certificate, etc.)

**OR**

Applicants age sixty-four (64) and under, must present a statement on letterhead from a physician licensed to practice medicine in Mississippi, certifying that the applicant has a disability which totally and permanently prevents this person from using a long bow or other conventional archery equipment. (This statement must be on physician's letterhead and signed by the physician, not stamped.) Also send copy of driver's license. If disabled, see proof required below in Item 3.

**AND a copy of one (1) of the following:**

1. Current year sportsman license or current year hunting license *and* archery-primitive weapon permit *or*
2. Lifetime license *or*
3. Proof of disability - (Social Security Administration - a TPQY or disability letter; Veterans Administration - a letter stating total service connected disability; Railroad - a letter stating totally disabled by Railroad Retirement Board).  
**Proof of disability should have current year date if obtained through Social Security Administration.**

**NON-RESIDENTS**

**Crossbow Fee \$10.00 + Process Fee \$0.85 = Total Cost \$10.85**

Applicants age sixty-five (65) or older, must present proof of age (copy of driver's license, birth certificate, etc.) *or*

Applicants age sixty-four (64) and under, must present a statement on letterhead from a physician licensed to practice medicine in Mississippi, certifying that the applicant has a disability which totally and permanently prevents this person from using a long bow or other conventional archery equipment. (This statement must be on physician's letterhead and signed by the physician, not stamped.) Also send copy of driver's license.

**AND a copy of one (1) of the following:**

1. Current year of any non-resident all game hunting license *and* archery/primitive weapon permit *or*
2. Current year of 3-day all game /archery-primitive weapon permit *or*
3. Non-Resident Mississippi Native Lifetime license

NOTE: DEER AND TURKEY MAY BE HUNTED, BY SPECIAL LICENSE, WITH A CROSSBOW DURING ANY OPEN SEASON ON DEER AND/OR TURKEY SEASONS. SMALL GAME MAY BE HUNTED, BY SPECIAL LICENSE, WITH A CROSSBOW ONLY DURING THOSE PERIODS WHEN OPEN SEASON FOR THE PARTICULAR SMALL GAME ANIMAL COINCIDES WITH ANY OPEN SEASON ON DEER.
